### PUBLIC NOTICE ON THE DRAFT MARBLE HALL PRECINCT PLAN

Ephraim Mogale Local Municipality following a resolution made by Council at its meeting held on the 31<sup>st</sup> of August 2022, hereby gives a notice, in terms of Section 12(3) and Section 18 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000), as amended, of its intention to make the Marble Hall Precinct Plan public.




