The following compulsory documents must accompany the proposal (failure to provide such documentation will lead to automatic disqualification): • Original valid Tax Clearance Certificate • B-BBEE Certificate • Certified copies of company certificates • Proof of experience in this field • Certified copies of the IDs of Directors • Municipal account not older than three months/valid lease agreement • Company profile.

A preferential point system will apply whereby this project will be allocated to a tenderer in accordance with the PPPF Act (No 5 of 2000), and as defined in the conditions and requirements of this project in terms of the Supply Chain Management Policy of the Municipality. This tender will be adjudicated on functionality using the following point system: 90/10 if the value is more than R1 000 000.00.

Ephraim Mogale Local Municipality reserves the right to accept or not to accept the lowest priced or any other proposal. No correspondence will be entered into with any tenderer regarding scores obtained, reasons for no appointment, etc. No late, telephonic, facsimile and/or e-mailed tenders will be accepted.

According to the Municipal Supply Chain Regulations issued by the Minister of Finance, in terms of section 168 of the Municipal Finance Management Act (56 of 2003), a person within the organ of State, such councillors and other elected representatives, full-time employees and other directors of public and municipal entities are prohibited from tendering or being awarded a contract to provide any services to the Municipality.


