

# BID NOTICE AND INVITATION TO BID



## EPHRAIM MOGALE LOCAL MUNICIPALITY: TENDER NO: TENDER EPMLM/INFRA/8/3/136

Bids are hereby invited for **Dichoeung Internal Streets for the 2014/2015** in Ephraim Mogale Local Municipality in Limpopo. The contract entails the construction of **2,55km** long and **7,0m** wide road **within an average road reserve of about 30m** to be paved with **ASHPHALT SURFACING** and the construction of associated open channel stormwater **side drains in the form of an open trapezoidal channel** along the roads to be constructed.

Access to the project from the centre of Marble Hall Town (Ephraim Mogale Municipal Offices) is obtained by travelling on the R519 road towards East to **Zebediela/Lebowakgomo** for about 32km pass Elandskraal-A towards **Dichoeung /Doornpoort**.

The co-ordinates are: Start of Road: 24° 38' 10.46" South and 29° 27' 40.60" East  
End of Road: 24° 39' 10.96" South and 29° 27' 23.66" East

Only bidders who comply with the following requirements are eligible to submit tenders:

- Register with CIDB and having a grading of **7CE or higher**.
- Bids will be evaluated on the 90/10 points system.
- Tenders will be evaluated on functionality with a minimum qualifying score of 60 points.

Tender documents will be obtainable as from Monday the **30<sup>th</sup> June 2015** at the offices of **Ephraim Mogale Local Municipality** (not on site), in Marble Hall, upon payment of a non-refundable amount of R500.00. Only cash or bank guaranteed cheques made out to Ephraim Mogale Local Municipality will be acceptable.

A compulsory site inspection will be held on Friday the **03<sup>rd</sup> July 2015** at **11:00**. Prospective tenderers are requested to meet the Engineer and the Municipality representative at "**Dichoeung village**" **Dichoeung Post Office Service Centre Offices** at the front gate. The Engineers will lead all prospective tenders through the proposed site. Only tenders from tenderers who attended the above site inspection meeting will be considered. **It is compulsory for all partners in an entity intending to bid as a Joint Venture (JV) to all attend briefing meeting.**

All bids will remain valid for a period of ninety (90) days after the time and date of opening (28 October 2015). Late submissions, telegraphic, telefax or e-mail transmission tenders will not be accepted. Ephraim Mogale Local Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept a tender as a whole or in part.
