Bids are hereby invited for the construction of Rathoke internal streets in Ephraim Mogale Local Municipality in Limpopo. The contract entails the construction of new layer works and asphalt surfacing of 1km long project.

Bid documents are available from the office of the Supply Chain Management, Ephraim Mogale Local Municipality. It is estimated that bidders should have a CIDB contractor grading of 5CE or higher.

Only bidders who comply with the following requirements are eligible to submit bids:

- Register with CIDB and have a grading of 5CE or Higher
- Bids will be evaluated on the 90/10 points system
- Bids will be evaluated on the functionality with a minimum qualifying score of 60 points.

Plant and equipment necessary for construction	30
Specific personnel knowledge	20
Bank rating/financial standings	10
Total points for functionality	100

Only bidders who can demonstrate that they will have in their employ staff which satisfies EPWP requirements during the contract validity are eligible to submit bids.

Bid documents will be obtainable as from Tuesday, 24th of January 2017 at the offices of Ephraim Mogale Local Municipality (not on site) in Marble Hall, upon of a non-refundable amount of R550.00; only cash or bank guaranteed cheque made out to Ephraim Mogale Local Municipality will be acceptable.

A compulsory site inspection will be held on Friday, 27th of January 2017 at 11:00. Prospective bidders are expected to meet the representative of the Engineer at Rathoke Villiage. GPS Coordinates: 24°56'30"142S 29°03'16.708"E.

All bids will remain valid for a period of ninety days after the time and date of opening. Late submissions, telegraphic, or e-mail transmission bids will not be accepted.
