BID NOTICE AND INVITATION TO BID

BIDS ARE HEREBY INVITED FOR THE CONSTRUCTION OF MASHEMOMO/MOOIHOEK INTERNAL STREET: PHASE 1 IN EPHRAIM MOGALE LOCAL MUNICIPALITY IN LIMPOPO. THE CONTRACT ENTAILS THE CONSTRUCTION OF NEW LAYER WORKS AND ASPHALT SURFACING OF 3.9 KM LONG ROAD PROJECT.

Bid documents are available from the office of the Supply Chain Management, Ephraim Mogale Local Municipality. It is estimated that tenderers should have a CIDB contractor grading of 7CE or higher.

Only bidders who comply with the following requirements are eligible to submit bids:

- · Register with CIDB and having a grading of 7CE or Higher.
 - Bids will be evaluated on the 80/20 points system
 Bids will be evaluated on the functionality with a minimum qualifying score of 70 points.

Only bidders who can demonstrate that they will have in their employ staff which satisfies EPWP requirements during the contract validity are eliqible to submit bids.

Bid documents will be obtainable as from Friday the 06th July 2018 on the etender portal site and the offices of Ephraim Mogale Local Municipality (not on Site), in Marble Hall, upon payment of a non-refundable amount of R500 cash or bank guaranteed cheque made out to Ephraim Mogale Local Municipality will be acceptable.

A compulsory site inspection will be held on Tuesday the 10th July 2018 at 10:00 Prospective bidders are expected to meet the representative of the Engineer at the main entrance of Ephraim Mogale Local Municipality Town Hall in Marble Hall, 3rd Avenue, from where they will be accompanied to the site. All bids will remain valid for a period of ninety days after the time and date of opening. Late submissions, telegraphic, telegraphic or e-mail transmission bid will not be accepted. Ephraim Mogale Local Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept a bid as a whole or in part.
