The projects will be subjected to functionality (quality) evaluation, whereby a minimum qualifying score of 60% will be required for bidders to be further evaluated for procurement points, and a minimum qualifying score of 70 points on the construction of Mashemong/Mooihok Internal Street. The Municipality will adjudicate and award bids in accordance with the B-BBEE status level of contribution, using the 80/20 preference point system, where 80 points will be allocated to price and 20 to B-BBEE level of contributor. Bids will remain valid for 90 days after the closing date.

Completed bids in sealed envelopes, clearly marked with the relevant bid number and description, should be deposited in the bid box situated at the offices of the Ephraim Mogale Local Municipality, 2 Ficus Street, Marble Hall 0450, where bids will be opened in public. Bids not clearly marked and in sealed envelopes will not be considered.
