A minimum qualifying score of 60% on relevant projects will be required on functionality for bids to be further evaluated for procurement points.

Completed bids in sealed envelopes, clearly marked with the relevant bid number and description, should be deposited in the bid box situated at the offices of the Ephraim Mogale Local Municipality, 2 Ficus Street, Marble Hall 0450, where bids will be opened in public. Bids not clearly marked and in sealed envelopes will not be considered.
