Bids are hereby invited for the **CONSTRUCTION OF ELANDSKRAAL INTERNAL STREET PHASE 2** in Ephraim Mogale Local Municipality in Limpopo. The Contract entails the construction of new layer works and asphalt surfacing of 1.4 km long project.

Bid documents are available from the office of the Supply Chain Management, Ephraim Mogale Local Municipality. It is estimated that bidders should have a CIDB contractor grading of 6CE or higher.

Only bidders who comply with the following requirements are eligible to submit bids:

- Register with CIDB and having a grading of 6CE or Higher
- Bids will be evaluated on the 90/10 points system
- Bids will be evaluated on the functionality with a minimum qualifying score of 60 points.

Only bidders who can demonstrate that they will have in their employ staff which satisfies EPWP requirements during the contract validity are eligible to submit bids.

Bid documents will be obtainable as from Monday, **03 November 2016** at the offices of Ephraim Mogale Local Municipality (not on Site, in Marble Hall, upon of a non-refundable amount of **R550** only cash or bank guaranteed cheque made out to Ephraim Mogale Local Municipality will be acceptable.

A compulsory site inspection will be held on Monday the **07 November 2016** at 12:00. Prospective bidders are expected to meet the representative of the Engineer in Elandskraal at co-ordinates Latitudes-24.720233 and Longitudes 29.407954.
