It is compulsory for one partner in an entity intending to bid as a Joint Venture (JV) to attend briefing meeting

Only tenderers who are registered in the relevant category with the Construction Industry Development Board (CIDB) will be considered. The bidding company shall have CIDB grading designation of 3CE or higher. In cases of companies tendering as JV's it is therefore a requirement that all JV partner provide proof of having registered with the CIDB. Tenderers MUST provide a certified copy of B-BBEE Status Level Verification Certificate for the company and in the case of Joint ventures each company must submit a B-BBEE Status Level Verification Certificate. The bid will be evaluated and adjudicated in accordance with the 90/10 point system as outlined above and in terms of the PPPFA.2000 (Act No. 5 of 2000) and the regulations and the supply chain management policy of the EPHRAIM MOGALE LOCAL MUNICIPALITY.
