DESCRIPTION OF WORKS

General Description of the project

The project is the supply of the required material and the construction of two 250meter sections of Aerial Bundle Conductor. The supply and delivery of two meter kiosks and 6 LED flood lights.

Employer's Objectives

The employer's objective is to provide a temporary electrical supply and public lighting for the annual cultural festival.

EXTENT OF WORKS

The scope of work comprises of the following and is based on the ESKOM specification **where not otherwise specified:**

- Construction of 250meters of 70mm² Aerial Bundle Conductor
- Construction of 250meters of 25 or 35mm² Aerial Bundle Conductor
- Supply and deliver 6 LED flood light
- Supply and delivery of two special distribution kiosks

Note: The description of the works is not necessarily limited to the above items.

70mm² ABC Overhead Line Specification

1. According to ESKOM specification
2. 3 Core and Neutral
3. 9meter SABS Eucalyptus poles
4. 50 meter pole spacing
5. Anti-climb devices
6. Standard conventional stay wires
7. Re-usable electrical connection clamps sets at poles: 1, 4 and 6

25mm² or 35mm² ABC Overhead Line Specification

1. T-Off from pole 5 on 70mm² line
2. According to ESKOM specification

There must be no wiring in the front – plug socket outlet side

LED Flood light Specification

The flood lights will be used to for general illumination of open public space during the Diturupa Festival. The lights will be installed on the two 11meter poles at a spacing of 150 meter. Each pole will be fitted with 3 LED floodlights. The electrical supply is from a generator with possible frequent small deviations from the nominal declared national voltage. The mast is in a very hot climate and the luminaires must be able to operate under these conditions.

A. GENERAL GUIDELINES: (wide symmetrical beam)

The LED luminaire shall be designed to meet the lighting criteria for high mast lighting with a wide symmetrical beam and a fluctuating supply voltage. The luminaire shall be designed in accordance with the following requirements:

1. Design life: In excess of 25 years
2. Minimum IP rating of the light compartment, including driver compartment: IP 66.
3. The protector shall be smooth, for easy cleaning, and shall be manufactured of tempered high impact glass (IK08)
4. The luminaire shall be equipped with efficient thermal management of both the LEDs and the power supply.
5. The optical unit and the control gear compartment shall be separated.
6. The cooling fins must optimise the heat dissipation and the luminaire must be able to manage high ambient temperatures (T_a up to 55°C) and remain reliable in the long term.
7. The thermal design shall be particularly designed for African exterior conditions, i.e. high

temperatures, high pollution, corrosion resistant.

8. It shall be certified, in terms of SANS (IEC)60598-2-5 specific to floodlights
9. It shall comply to the following standards:
IEC 55015 "Limits and methods of measurements of radio disturbance characteristics of electrical lighting and similar equipment"
10. The LED life expectancy shall be 60,000 hours at 80% lumen maintenance at a current of 1000ma or 100,000 hours at 90% lumen maintenance at a maximum of 700ma (Documentary evidence from the LED manufacturer, by means of an appropriate datasheet, confirming the statistical correlation, shall be provided).
11. Use of high efficiency LED's (> 117 lumens/watt: Absolute photometry) CRI > 70. Documentary evidence of compliance to this clause shall be submitted with the tender.
12. Colour temperature shall be neutral white (4000K). A report from the LED vendor, for LED's used in the luminaire, shall be submitted, which shall include the following documentary evidence:
 - LED drive current.
 - LED manufacturer data that clearly correlates LED junction temperature and LED drive current to lumen maintenance.

B. PHOTOMETRIC REQUIREMENTS:

The tenderer shall submit the detailed calculations as per the installation description and confirm the results by attaching the photometric data based on measurements undertaken by an internationally certified lighting laboratory. This photometric report shall contain the measuring matrix and the calculation shall be based on the following criteria:

- LED lumen depreciation: 20%
- Maintenance factor: 0.9 (allowing for a 10% light loss due to dirt on the protector surface).

C. POWER SUPPLY:

Due to the instability of the rural overhead networks and the goal of achieving energy as well as operating and maintenance costs the supply shall comply with:

- The power factor shall be rated at ≥ 0.92
- The power supply shall be removable and shall be suitable for operation with the specified rating of the lamp on a **108-305VAC** 50Hz **single phase** system.
- Operating temperatures shall be from -40deg to +55deg
- Operating humidity up to 90%.
- The control gear shall incorporate a thermal switch for protection when exceeding the case temperature.
- The unit shall be EMC compliant to the EN55015 and EN61347-1 standard.
- The unit shall be able to withstand surges up to 10kV/10kA by means of an external surge

protection device mounted inside the gear compartment and shall be easily replaceable.

D. DETAILED LIGHTING DESIGN:

Detailed lighting designs must accompany the tender clearly indicating compliance to specification as indicated elsewhere in this tender.

- Number of LED's should be more than 140
- Light colour should be 4000K
- The main lens of the luminaire must be flat, tempered, clear glass with serigraphy.
- The luminaire must be equipped with a suitable mounting bracket to fit the standard mounting system used by Sectional Poles. (Typically an adjustable square steel arm)
- Energy consumption must not exceed 480Watt
- Main body must be manufactured from aluminium and must be powder coated.

E. WARRANTY

A warranty signed by the manufacturer must warrant that the goods supplied under the contract are new, unused, of the most recent or current models and incorporate all recent improvements in design and materials. The manufacturer must further warrant that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the manufacturer, that may develop under normal use of the supplied goods in the conditions prevailing in Marble Hall, Limpopo, South Africa.

The manufacturer must warrant that each luminaire supplied under the contract shall have a maximum lumen depreciation of not more than 10% of the original lumen output of the luminaire during the period of warranty.

This warranty shall remain valid for thirty-six (36) months after the goods or any portion thereof as the case may be, have been delivered.

The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

Upon receipt of such notice, the manufacturer shall, within the specified period and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

If the manufacturer, having been notified, fails to remedy the defect(s) within the specified period, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;

- 2.15 **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.

- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other

enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.

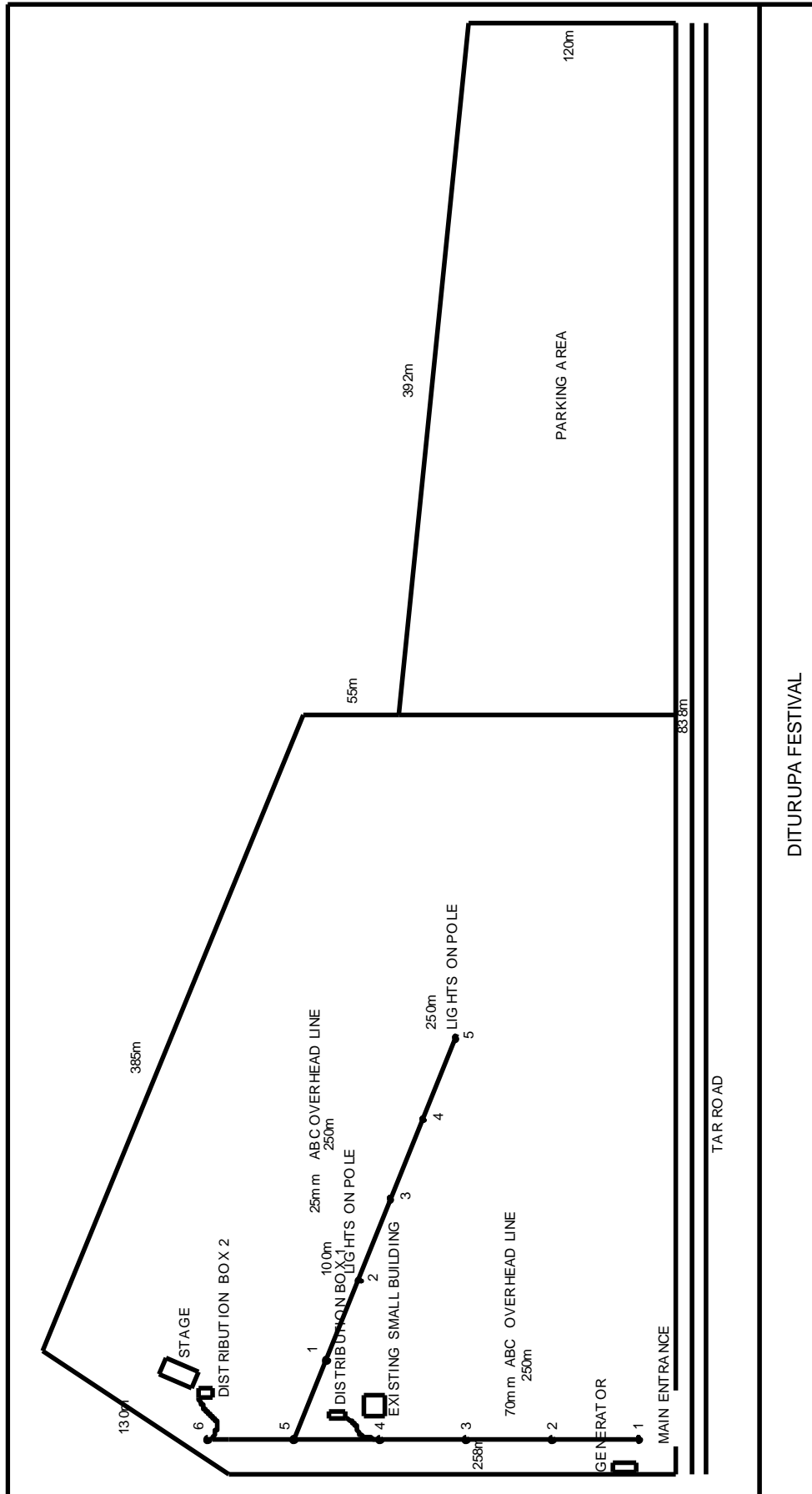

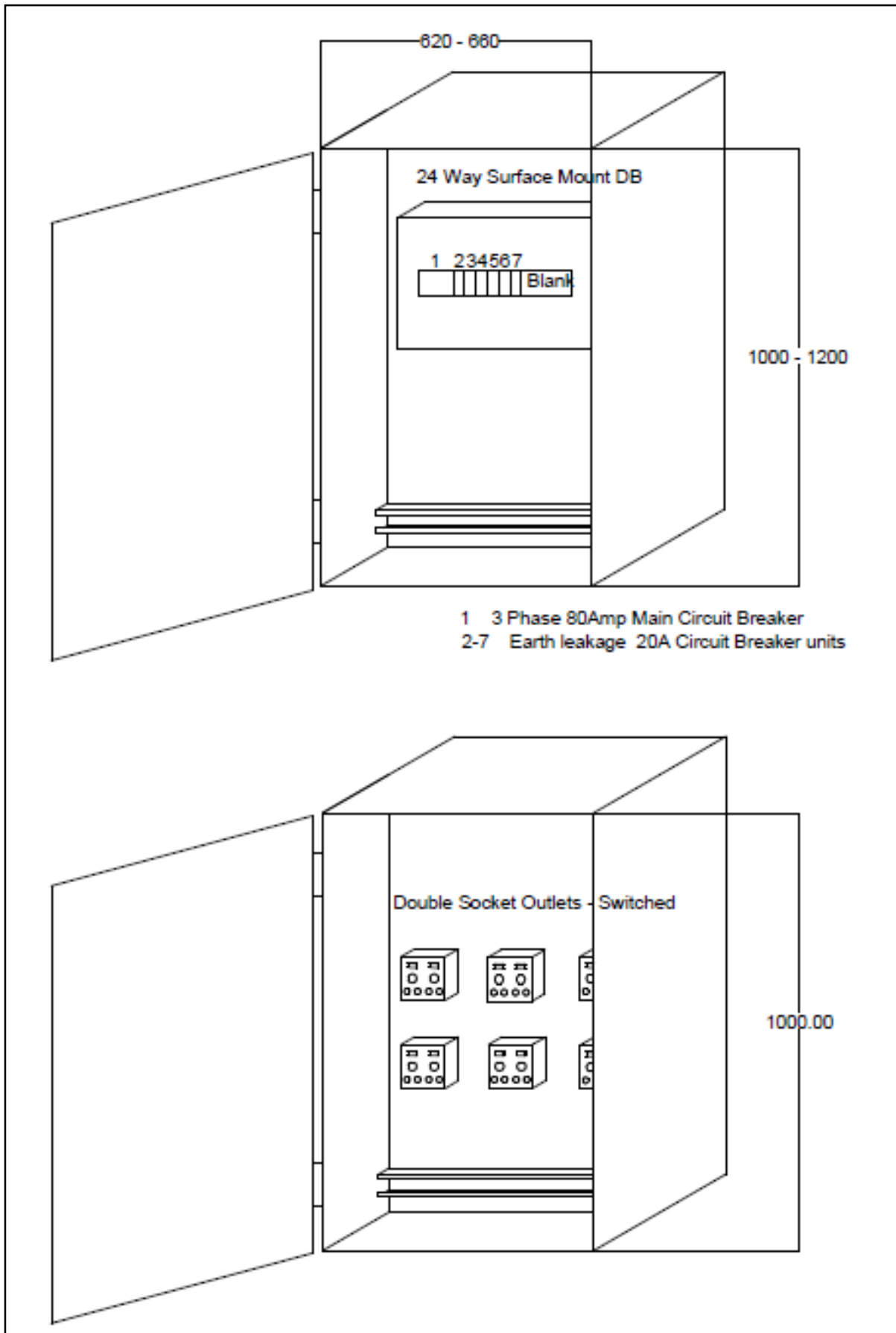
