1. BACKGROUND

Ephraim Mogale local Municipality is located in Marble Hall Town with satellites offices in Leeuwfontein, Elandskraal, Zamekomst and Moomane. The Municipality is consists of more 66 villages.

Maintenance of the internal streets / roads and waste collection is the function of the Municipality. The Municipality roads have a fully-fledged maintenance division within the Infrastructure department. The backlog is currently sitting at 990km and a lot of additional extension in various villages are mushrooming. Due to the abovementioned issues, we have identified the need to appoint a suitable service provider/s who will be engaged in a service level agreement with Ephraim Mogale local Municipality as and when required for a period of 36 months.

Work shall be completed and invoiced within five days from date of commencement or at agreed timelines depending on the nature of work at hand. Submit all relevant and required documentation as per scope of work detailed above herein.
