Veteran midfielder hopes
to debut away to Baroka

Former Kaizer Chiefs and Mamelodi Sundowns midfield dynamo George Maluleka has joined second-tier rookies Kruger United, the Mpumalanga side announced yesterday.

“Kruger United Football Club is pleased to announce the signing of George Maluleka. The 35-year-old brings experience to the team having played for Kaizer Chiefs, SuperSport United and AmaZulu.

The Kruger nation welcomes you to the family and wishes you well. Welcome Maluleka,” the club said in a statement.

Maluleka had been clubless after leaving AmaZulu at the end of last season, where he played 17 games across all competitions. The central midfielder is believed to have penned a one-year deal with Bushbuckridge-based Kruger, who were promoted to the Motsepe Foundation Championship (MFC), courtesy of being the runners up at the ABC Motsepe National playoffs, in June this year.

“S’jijo”, as Maluleka is affectionately known in football spaces, boasts over 360 topflight appearances.

It remains to be seen whether the well-travelled midfielder will make his debut for Kruger as they face Baroka in their fourth game of the season away on Saturday.
