Quotations must be in a sealed envelope and reach the municipality on or before 12:00 am on 21 August 2012 at: Municipal Offices, 13 Ficus Street, Marble Hall, and TENDER BOX.

Quotations must be in writing and must clearly indicate the relevant supply or service for which is being quoted. Bids transmitted by fax or e-mail will not be accepted, although Ephraim Mogale Local Municipality accepts no responsibility for ensuring that quotations are timeously received by Ephraim Mogale Local Municipality.

Quotations will not be considered unless the following information has been furnished:

- (i) Full name;
- ii) Copy of identification document or registration documents of your company/close corporation
- (iii) Valid Tax Clearance Certificate issued by SARS;
- (iv) VAT registration number, if any;
- (v) If a natural person, whether he or she is or not in the service of the state, or has been in the service of the state in the previous twelve months; or
- (vi) if not a natural person, whether any of its directors, managers, principal shareholders or stakeholders is in the service of the state, or has been in the service of the state in the previous twelve months; or
- (vii) Whether a spouse, child or parent of the provider or of a director, manager, shareholder or stakeholder referred to in (vi) is in the service of the state, or has been in the service of the state in the previous twelve months.

("in the service of the state" means to be -

- (a) A member of any municipal council, any provincial legislature, the National Assembly or the National Council of Provinces;
- (b) A member of the board of directors of any municipal entity;
- (c) An official of any municipality or municipal entity;
- An employee of any national or provincial department, national or provincial public entity or constitutional institution within the meaning of the Public Finance Management Act, 1999 (Act No 1 of 1999);
- (e) A member of the accounting authority of any national or provincial public entity; or
- (f) An employee of Parliament or a provincial legislature)
- (g) This quotation must be accompanied by duly completed MBD 4 Form(declaration of (declaration of interests) and MBD6.1 form(Preference points claim form in terms of

Preferential Procurement Regulations 2011)obtainable from supply chain management unit offices during offices hours (8h00-16h30)

Important Note:

- Quotations with a value over R30 000 (VAT included) <u>must</u> be accompanied by a tax clearance certificate from the South African Revenue Services that provider's tax matters are in order;
- (ii) In terms of Preferential Procurement Regulations of 2011, the 80/20 preference point system is applicable. Broard Base Black Economic Empowerement (B-BBEE rating claim. Failure to submit such certificate will result in bidder not qualifying for Preference points for B-BBEE. The bidder must submit verification certificates that are accredited by

SANAS(South African Accredited System) IRBA (Independent Regulatory Board of Auditors)

Points will be awarded to a bidder for attaining the B-BBEE. Status level of the contributor.
