BACKGROUND

The Municipality has a relatively small economy, contributing only 1% to the provincial value of production. The Municipality is one of the five municipalities forming Sekhukhune District Municipality, which is the second poorest district in South Africa's nodal points identified as poor and requiring careful developmental solution.

Tourism in Ephraim Mogale Local Municipality involves activities associated with individuals traveling to or passing through the area for leisure, business, and other purposes. The tourism industry presents a range of economic opportunities for local businesses and residents. Tourists spend money on accommodation, food, retail shopping, entertainment, and transportation, which boosts the local economy. Ephraim Mogale encompasses many game reserves around it that should be further empowered and invested in, to attract more visitors to the municipality.

Marketing and Promotion requires campaigns to raise awareness of the municipality's tourism offerings through various marketing tools, including digital platforms and partnerships with tourism agencies.

2.1 Geographic Information

The Municipality is in Limpopo, in Marble Hall town, on the western banks of the Olifants River. The town of Marble Hall lies north of Pretoria and is situated approximately 150km south of Polokwane. It consists of 16 Wards and 32 councilors.

2.2 Tourism

2.2.1. Currently the tourism sector is improving with the development of Lodges and guest-houses in the rural areas but remain uncoordinated due to lack of organized structure, some of are not visible to potential tourists.

The main challenge facing tourism as sector is the lack of an anchor tourism attraction and makes it difficult to market Ephraim Mogale as a tourism destination.

The tourism sector has significant potential for development but is currently underdeveloped as far as the infrastructure and the marketing is concerned.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
