An application for a Building Line Relaxation will not be considered unless the following matters have been addressed:

1. A proof of Relevant application fee: R 1,600.23+ R20.00/m<sup>2</sup>;
2. Transgressions without prior approval for a structure which can be approved:  
Penalty fee: R1, 502.57;
3. A written consent from the affected neighbor(s) to be attached, indicating that the erection of such building(s) or structure(s) will not cause any disturbance and can therefore be approved by the Municipality;
4. Copy of the tittle deed;
5. Power of attorney to be attached, If not the registered owner of the property;
6. A copy of the plan drawn on a scale must be attached to the application, which clearly shows the property and the surrounding area with roads, proposed and existing building(s) with the distances from the erf boundaries and buildings opposite the road, as well as adjacent to the site. The actual area of the property as described in the tittle deed or on the general plan, as well as the erf number and extension must be indicated on the sketch;

7. The provisions of the National Building Regulation and Building Standard Act 103 of 1977, must be conformed to.
